I discussed your concerns with the layby with the planning agent and he has come back with the following response:

The layby

In response to your email yesterday, I can advise that the layby on the access road is for servicing only, for the café. It has been included as part of the design from the outset, following the preapplication discussions that took place. There was a desire to try and strike an appropriate balance between preventing van drivers just stopping on the access road, maximising the amount of landscaping and maintaining access to Cigarette Island. With the very limited amount of time the access would be in use and the short duration that a service vehicle for the café would be there, it was felt that the right balance had been struck. However, if there are now concerns, the Servicing Management Plan that we have offered to provide, can explore this further to come up with something that is acceptable. For example, the café servicing could be restricted to hours when your maintenance teams will not need it.

Replacement trees

Regarding the replacement of any trees removed in the construction of the temporary car park, I can advise that in accordance with the recommendation of the Elmbridge Tree Officer, the number of trees proposed to be removed increased to four (along the western boundary of Cigarette

Island). As part of the proposal, 31 new trees are proposed within the main part of the site and in addition, the applicant has agree to your request previously to fund additional planting within Cigarette Island itself.

Coach parking

In addition to these two points, when we spoke on the 'phone, you briefly mentioned coach parking. From the applicant's previous discussions with hotel operators, there was no requirement for any coach parking to be provided, as a hotel in this location would not cater for coach tours. However, as part of the proposal, a large layby is proposed immediately in front of the hotel, which could be used to drop off/pick up hotel guests, in the unlikely event that there was a need.

This layby would not be suitable for Hampton Court Palace to use, but it is clearly not the joint applicant's responsibility to provide the Palace with coach parking. The Palace directs coaches to park on Hampton Court Green, so it already has a location it uses.

I hope this helps to clarify the position, however if you require further information or feel we do need to secure more details of the plan for the layby please let me know.

Further to previous correspondence regarding this development the Green Spaces / leisure team have now reviewed the updated documents and have one further item we would like clarified and one comment.

The new proposed vehicular access road into Cigarette Island appears to have a potential layby, prior to the access of the entrance road. We have concerns that this may, by its nature and location, unintentionally encourage parking / drop offs which could impede vehicle access for maintenance / emergency vehicles into Cigarette Island.
